I am writing today in support of TD Bank (TD) and in recognition of the relationship that the Delaware Council on Economic Education (DCEE) has with TD Bank. We have received volunteer support from TD Bank since 2008; we have received annual financial support for Delaware programming since 2013.

The DCEE believes that all students, regardless of zip code or socioeconomic standing, need to be well grounded in financial and economic content. Related knowledge and skills are essential for a financially sound future. Accordingly, the DCEE's state-wide programming promotes the teaching of economics and personal finance to students in grades K-12. Several programs specifically target schools in which a significant number of low-to-moderate income (LMI) students are enrolled. Ensuring that teachers are properly outfitted to effectively deliver this type of education-- both early and throughout the K-12 experience-- increases the likelihood that students will graduate with the tools needed to one day enjoy a higher standard of living.

One such DCEE-supported program that delivers this critical instruction to Delaware students, beginning at a young age, and which requires the help of over 200 area bank volunteers annually is Teach Children to Save Day (TCTSD)-- part of a nationwide financial literacy effort working to educate elementary school students on the importance of saving as the basis for future financial security.

TCTSD draws volunteers from 75% of Delaware's banks. TD is always represented among those partners. This year, volunteers are scheduled to teach 7,200 students in 65 different elementary schools throughout the state. At the start of each TCTSD event, Delaware's Governor signs a proclamation, highlighting the importance of saving and inviting both bankers and teachers alike to participate, stressing that the ethic of saving should be instilled early. TD Bank is committed to TCTSD and to similar community investment programs that focus on education and financial literacy priorities, encouraging their employees to volunteer for this particular program since 2016.

Because TD Bank is as committed to adult financial literacy as it is to related K-12 education, they have previously partnered with DCEE to co-produce parent and family nights in schools through the Personal Finance Academy (PFA). In addition to providing annual funding for PFA student- and teacher-training programming, TD provides volunteers who offer lessons to parents. While their children participate in evening in-school math and personal finance games, parents attend TD volunteer presentations to help families manage their finances more successfully. Topics that volunteers present on include Building and Maintaining Great Credit, Breaking the Paycheck to Paycheck Cycle, and Protecting Your Identity. As part of this program, TD has also sponsored visits by the Food Bank of Delaware's mobile pantry so that parent night participants could also receive free fresh produce and assorted food and non-perishables.

We appreciate TD Bank's commitment to both Teach Children to Save Day and the Personal Finance Academy and commend them for demonstrating a lasting and outstanding commitment to related K-12 teacher training and student programming throughout Delaware.

Additionally, TD SVP Regional Vice Presidents for Delaware have served as board members for the Delaware Council on Economic Education, first offering their leadership in November of 2008. Currently Lisa Kirkwood serves as DCEE's Vice Chair, first joining the DCEE Board in 2017. Under her leadership, TD remains a visible and dedicated advocate for K-12 personal finance education, encouraging employee volunteer involvement in personal finance, economics, and entrepreneurship educational programs for Delaware students.

On behalf of the DCEE, I am delighted to support TD Bank in their application to receive approval to acquire First Horizon. We know they will continue their outstanding work in our community, and we look forward to working with them on additional projects in the future.

To whom it may concern:

As Florida's leading statewide community development financial institution (CDFI), the Florida Community Loan Fund (FCLF) would like to comment positively on the above acquisition.

For nearly thirty years FCLF has successfully financed community development in Florida. Since inception, FCLF has financed \$494 million through 411 loans, into projects that have leveraged over \$1.3 billion. FCLF provides flexible financing for mission-based nonprofits and for-profit organizations engaged in affordable housing, supportive housing and projects offering essential social services, such as healthcare, education, and food access.

To achieve its mission, FCLF relies on operating grants to support its operations and on community development investments to support its lending. FCLF counts as its investors a wide range of religious investors, trade associations, foundations, individuals and hospital systems. But banks represent the largest portion of our total investment capital. The vast majority of large financial institutions with a Florida presence are both donors and investors in FCLF.

TD Bank and First Horizon are no exception.

On the investment side TD Bank (\$11.5MM) and First Horizon (\$1MM) are among the investors in FCLF. Debt capital from both banks allows FCLF to deploy financing to a wide

range of community projects statewide. Relative to their size and market share in Florida, both banks are among the most active investors in FCLF.

Both banks have also supported FCLF through operating grants. Support of this kind has been reasonable and relatively consistent, but not as large or as consistent as other peers relative to their asset size and market share.

Beyond investments and operating support TD Bank's Ana Castilla, Vice President, FL Regional Community Development Manager participates on our board and committees. TD bank has been a good business partner through a depository relationship and we feel that the bank values FCLF and other nonprofits as bank customers and provides a high level of attention to those relationships.

Overall, we find both TD Bank and First Horizon separately take their role in community development seriously and have been thoughtful about meeting their CRA responsibilities. We do not have a reason to believe that the commitment to community development would decrease for the resulting combined entity.

One important caveat in our recommendation is that we would hope and anticipate that the resulting entity expands its community development work in Florida. Of specific concern, as with any merger of two banking institutions that are separately investors in FCLF, is the potential that the combined investments would be deemed outside of the concentration of risk parameters for the resulting entity. We believe, based on past experience with both of our partners, that the resulting entity will recognize the importance of maintaining and growing the relationship with FCLF.

Please accept this letter in support of TD Bank (TD) on behalf of Germantown United Community Development Corporation's (GU) leadership. TD and GU have an important relationship-the bank is our corporate partner in the City of Philadelphia's Community Development Corporation (CDC) Tax Credit program, which has been a transformative tool for our organization.

Many markets in Philadelphia's outlying neighborhoods and commercial corridors are weak and do not yet have enough taxable economic activity to create a Business Improvement District or self-fund through a membership program. This is the case in the Germantown neighborhood (19144 and 19138), which is GU's service area. Germantown is one of the most historic, economically and racially diverse, and civically active communities in Philadelphia. However, we are not without challenges-Germantown has been the victim of decades-long disinvestment and economic decline. Located where North Philadelphia meets the more affluent Northwest neighborhoods of Mount Airy and Chestnut Hill, household incomes reflect this area as a transition point in the city: 47% of households earn \$25,000 or less per year and 35% of Germantown households are housing-cost burdened¹. The majority of Germantown residents are black and percentages have increased since 1990. Germantown proper is 77% black, 15% white, 3% non-white Hispanic, and 2% Asian; East Germantown is 92% black, 3% white, 2% non-white Hispanic, and 2% Asian².

The tax credit program continues to be a vital and creative funding stream for our organization, and we are thankful to have TD Bank as our partner. Instead of paying \$100,000 annually in Business Income & Receipts Tax (BIRT), a qualifying business, in our case TD Bank, contributes \$100,000 for 10 consecutive years to a qualifying nonprofit, such as Germantown United CDC, and receives a credit against taxes due to the City from the Revenue Department. Tax credit contributions are specifically to be used by participating nonprofits for purposes of neighborhood economic development detailed in a written plan that is updated annually. GU's plan includes specific projects, plans of investment both public and private, job creation and retention, and overall economic growth, with concrete outcomes such as storefronts renovated, security cameras installed, bags of trash removed, promotional events completed, blighted buildings improved, etc.

Thanks to the support we receive from TD Bank, we are able to offer quality programs that support this work, our small business community and neighborhood residents. Despite the difficulties of 2021, we made tremendous progress on a number of important goals and objectives that will contribute to the long-term effectiveness of our organization and the economic success and revitalization of the neighborhood. Helping our residents and local businesses to navigate the many and always changing challenges of the COVID-19 pandemic continues to be a focus of our efforts in the past six months. For residents, we primarily serve as a resource to help identify, access, and coordinate community-based services, specifically around housing issues effecting low to moderate-income households. We support people facing evictions and foreclosures; facilitate access to emergency home repair, rental and utility assistance programs; and work to address other quality of life issues. For businesses, we connect businesses with financial resources to support storefront improvement projects; assist with the application process for grant/financing resources; support those that had to close temporarily, or are financially at-risk for permanent closure due to the pandemic; and more.

For the community at large, we continue to build-out our corridor cleaning program, a sidewalk sweeping service in the Central Germantown commercial corridor, helping to make our business and shopping environment clean, safe and accessible. GU now provides cleaning services five days per week, employing a crew of four Cleaning Ambassadors who provide stewardship and supplementary cleaning and maintenance services within Germantown's primary commercial artery. Since 1987, Habitat Hillsborough has been giving a hand up to diverse, low- and moderate-income families in our community through homeownership. Our goal is to help families break the cycle of poverty and build long-term financial security. Household income for Habitat homeowners is low to moderate, falling between 30% and 80% of Area Median Income. Successful candidates have steady income and the means to make monthly home payments, but cannot qualify for a traditional mortgage. Habitat Hillsborough offers a loan that keeps a new home's monthly payments affordable, no more than 30% of a family's income, even with taxes and insurance costs. In addition to securing their own stable and affordable home, Habitat homeowners begin to build wealth that will benefit their family for generations. Our work also helps address the racial gap in homeownership in the region: in fiscal year 2020, 58% of the new homes we constructed were purchased by Black families and 26% by Hispanic families.

Habitat Hillsborough has worked with TD Bank to secure funding through the Federal Home Loan Bank of Pittsburgh Affordable Housing Program. This has resulted in two significant awards that is assisting us as we build 2 neighborhoods. In addition, we were recently informed that we were awarded the Housing for Everyone grant that will fund the implementation of a credit repair program to ensure we are able to assist more families.


