I am writing on behalf of Self-Help in regards to TD Bank's proposed acquisition of First Horizon Bank.

Self-Help is a national community development financial institution (CDFI) with a mission to create and protect economic opportunity for all, especially for people of color, women, rural residents and low-wealth families and communities. Both TD Bank and First Horizon Bank have been strong partners of Self-Help's economic development and social justice work in recent years.

Most recently, in March 2022, First Horizon provided a \$15 million loan to support the preservation of affordable housing as the first bank investor in the Wake County Affordable Housing Preservation Fund. This fund was called for by Wake County in response the rapid loss of market rate housing units rented at affordable rates over recent years, and is made possible through patient, flexible capital from bank partners like First Horizon. Launching this summer, we expect this \$63 million fund to preserve or create more than 3,700 affordable housing units in the next 15 years. Fund design is already being used as a possible model for other geographies and we look forward to more partnership opportunity to come.

In 2020, TD Bank supported Self-Help's Paycheck Protection Program lending through a \$60,000 grant for local hiring and technical assistance contracting, helping us bring this essential federal resource to the communities we serve. Self-Help provided \$253 million in PPP loans to 2,799 borrowers, preserving 27,509 jobs. At a median loan size under \$21,000, 65% of our borrowers were businesses owned or led by people of color and more than half were located in low- or moderate-income census tracts.

In 2019, TD Bank and First Horizon each provided \$5 million to support Self-Help's small business, nonprofit and affordable housing lending in North Carolina, South Carolina and Florida. In 2020, First Horizon extended a separate \$2 million loan supporting low-income populations and communities that was originated by Community One prior to merger with First Horizon.

We expect that a joining of TD Bank and First Horizon will come with a continuing and expanding commitment to lending and investment to support low-wealth families and communities, both directly and through partnership with CDFIs like Self-Help.

Thank you for the opportunity to acknowledge and appreciate Self-Help's past partnerships with TD Bank and First Horizon.

Knothole is a collaboration of the U Deserve A Chance Foundation and the Carolinas Metro Reds, two organizations sharing similar missions of creating opportunities for disadvantaged youth and positively impacting West Charlotte communities. Knothole exists to provide quality education, recreation, connection and opportunity.
